Draft Amount **Number of Drafts**

- ⇒ The monthly draft is a **continuous membership plan**. I understand that my membership will remain in effect permanently or until I initiate its termination.
- ⇒ The payment draft program allows members to budget their membership over three months. Initial payment includes the member joiners fee. I understand that my membership will be paid for within the agreed payment plan and if I wish to terminate my membership a written notice is required, prior to the first day of the month.
- ⇒ I understand that if I (we) wish to terminate or change my draft membership in any way, I must give the YMCA **written notice prior to the first day of the month** in order to stop or change the draft in any way. Membership cards must also be returned to the YMCA prior to the last draft. Temporary cards will be issued for the remainder of time.
- ⇒ The YMCA may, at its discretion, adjust the monthly rate it charges for my (our) membership, I understand that I will receive at least 30 days notice prior to such changes.
- ⇒ Should a draft not be honored by my account for any reason, I understand that I will be responsible for payment to the YMCA along with a \$15.00 service charge.
- ⇒ I understand that after two unpaid drafts, the YMCA will immediately terminate my (our) membership until I (we) have brought all payments up to date.
