### **Q. How is my contribution used?**

### **Q. How much should I give?**

*A. Give what you can afford and what makes you feel good. Any amount provides valuable opportunities for individuals and families from all walks of life.*

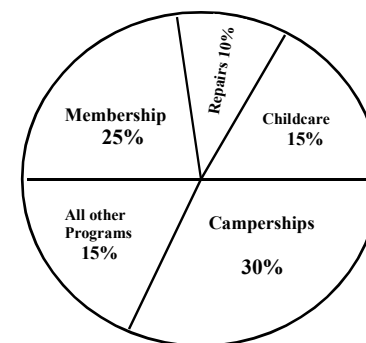
### **Q. Doesn't the YMCA generate revenue on its program and membership fees?**

*A. The fees the YMCA charges for programs and membership equal the total expenses of running all those activities. We need to raise annual support dollars to provide services to those who cannot afford the cost and to pay for capital improvements. Your gift to this fund helps keep costs down for everyone.*

## **WHAT YOUR GIFT DOLLARS DO ~**
